**Officers Reports:** Chair Tucker introduces VC Gary Ell and Treasurer Eric Gladwish, each gave a

report

Eric Gladwish informed the committee of the treasury update. He is still waiting for the majority of the required financial documents. The only thing received was documents from 2022 and a few documents from 2021. Documents are incomplete and missing records from 11/01/22 to year end. A year end treasurer report is required. Also, the State requirement is that the Treasurer must keep five (5) years financial records.

There was a \$280.00 balance left from the prior committee which has not been received. Our current committee has a negative balance of \$-657.00. On November 1<sup>st</sup> there was a balance of \$5,075.00 in the Administrative Account. Also, a balance of \$6,770.00 in the Election Fund Account, which can only be used for election related expenses. Currently there is no ledger of these expenditures. As of this meeting no funds have been transferred. We are expecting reports for these expenditures.

There was a check written to Spencer's for \$1000 for a deposit for a Christmas party by the previous committee members. All delegates were not invited. A note stated that the bill was for 42 guests and approximately \$1500 for this event. This party was flaunted on Facebook and the newly elected EC did not authorize this event. A \$1,000.00 check was written on 11/26/2022 and the new leadership took over on 11/28/2022. These transactions were not authorized by the new EC. The transaction of \$1,000.00 should have been canceled and refunded.

County bylaws state any expenditure over \$300.00 must be approved by the EC. Previous leadership made a motion and approved to allow the Chair the ability to spend any remaining funds. This is an amendment to the bylaws and must accompany a 30 day notice.

This is the current status of the treasury report.

Jim Conger stated that the previous treasurer Janet Stoney's duties remain until her term ends which is the end of the year for accountability. Janet Stoney hired an attorney and all correspondence must go through her attorney.

Chair Tucker explained it has only been 12 days and things are moving forward.

VC Gary Ell updated the committee that he had no current report and that the committees are being formed and put together.

William Wilkey, Suzanne Hall and Dan VanSumeren had concerns regarding accountability of the prior committee and us moving forward. This is currently being looked into.

### County Convention January 26, 2023 – Debra Ell

Debra Ell stated that everyone got a mailing for the Call to Convention. There will be a credential table to check in. We need all new credentials. They will be done in time for the January 26<sup>th</sup> convention meeting at the Saginaw Field & Stream at 1296 N. Gleaner Rd. Freeland, MI. which starts at 7:00 p.m. Get there at 6:30 p.m. and you will need a Picture ID.

County convention is to vote on the 37 delegates to go to State. There are also 37 alternatives. It requires a hotel stay as Friday night caucus and Saturday morning voting. We are District 8 which is Midland, Bay City, Saginaw, and Genesee. See Austin to be put on the ballot. Ballots will be printed ahead of time. There will be places for write-ins. You will get a packet from the State party when you are elected. You will need to know who to vote for before you get there. We need America First candidates. Fees are hotel stay/travel and the possibility of paying a fee for convention.
